Checks/Cash	<p>Send a check made payable to Florence Crittenton and acknowledge any memory or honor donations in the memo section or on a FC remit envelope.</p> <p style="text-align: center;">Florence Crittenton 3404 Cooney Drive Helena, MT 59602</p>	Check contributions do not require additional paperwork. However, if you have a matching gift program with your employer you may include that information and paperwork.	FCHS processes the check based on the postmark date , not the day the check is written. Please allow 1 week to receive your acknowledgment. Letter will state the post-mark date for date of gift.	POSTMARKED by December 31, 2022.

Public Securities	Send gifting instructions to your broker with the Ashton Thomas phone number of 406.389.8500 to call for account and transfer details.	Please make sure to alert FC of your transfer so that we can credit your account in a timely manner.	Timing depending on the broker processing the transfer. <i>*Transfers for 2022 guaranteed if requested by 12/27/22*</i>	Received by FC by December 31, 2022.
Deferred Payment Gift Annuity Using Stock or Cash	Even if you don't use the federal charitable deduction for a planned gift, the Montana Endowment Tax Credit can still be used to offset your Montana income tax liability because it is a dollar for dollar <i>credit</i> , not a <i>deduction</i> . Set up a meeting with FC to review annuity information and contract options. FC also holds an endowment account with the Montana Community Foundation for gift annuities.	Stock donations do take more time and require more information but are still a great option for the MT Charitable Tax Credit.	Allow 3 days for stock transfer and up to 2 weeks for agreement. <i>*Transfers for 2022 guaranteed if requested by 12/27/22*</i>	Stock donation must be received by Dec. 31, 2022 and any meeting <u>scheduled</u> prior to 12/31.
